**TRAFFIC AND PARKING REGULATIONS**

1. All students, at the time of this application for a parking space, must have a valid driver's license (NOT a learner's permit).
2. The speed limit on the school grounds is 10 miles per hour.
3. Seatbelts must be worn while on school property.
4. Students must park their motor vehicles in the designated parking area. DO NOT park in the service area, front of school, or on any grass areas, etc.
5. School buses will have the right of way at all times.
6. Parking signs and traffic patterns must be observed.
7. A registrant is responsible for his car at all times regardless of who may be using it.
8. Use extreme caution at all times when entering and exiting the school property due to the congested pedestrian and bicycle traffic.
9. All motor vehicles once parked must not be used until the end of the school day unless Office Permission is granted.
10. Drivers are not to allow other students to ride on exterior parts of their cars.
11. There will be no refunds issued because of loss of parking privileges.
12. No parking allowed in visitor parking spaces.
13. A student who fails to register a vehicle will be assessed a fee of \$5.00 per day for each day an unregistered vehicle is parked.

All students who drive to school must have their vehicles registered with the school office; have a valid Massachusetts license at the time when parking spaces are assigned; properly display a parking sticker; observe all traffic, parking and safety regulations. Registrants are responsible for being familiar with all regulations. Failure to observe these regulations or any action which endangers the safety of the school population will result in the removal of the privilege of driving to school and use of the parking lot. The school grounds are not public ways, but are under the jurisdiction and control of the School Department. **By applying for and accepting permission to park a vehicle at Ipswich High School the student acknowledges and agrees that the vehicle is subject to search by school officials when reasonable suspicion exists that banned materials or substances may be present.**

The privilege of parking on school property will be withdrawn for driving to endanger, speeding, issues of truancy or excessive tardies, parking in unauthorized spaces, and for students not in good standing because of their school conduct.
