## AFFIDAVITS OF RESIDENCY (To Be Completed by Property Owner)

Any applicant for the Ipswich Public Schools must produce a purchase and sale, property deed or lease in order to enroll into the Ipswich Public Schools. It is the responsibility of the applicant (not the person who completes this affidavit) to attach a record of recent payment, unless this affidavit affirms in number 3 below that the tenancy does not require payment of rent.
